#### Call to Order

#### **Minutes**

Highway 54 Coalition Meeting Review – Brenda reported that Kaye had supplied the 2016 Visitor's Guide to Pike County and they were delivered to MoDOT for distribution to Massman employees and MoDOT employees. MoDOT has clarified that unless there is legislation to change, a bridge remains unnamed and is known by what locals call it, so until there is legislation to change the name the bridge will continue to be known as Champ Clark. She reported there was a great networking opportunity after the Champ Clark bridge reception at RiverView Park at Overlook Farms near Clarksville. The Tri State Summit is supporting making Route 19 a four lane and testified to that at the hearing on June 29<sup>th</sup> to the Missouri Highway

and Transportation Commission. Brenda showed a map from the Tri State Summit website indicating what the potential impact would be to Pike County if Route 19 is made a four lane. The Highway 54 Coalition will continue working with Tri State Summit member to gain support for a shared 4 on Route 54. They will also start attending Council meetings of the towns particularly impacted. At some point, an Illinois Committee needs to be named to work with the Highway 54 Coalition. MoDot indicated at the meeting that there would not be funds to make Route 19 a 4 lane and also make Route 54 a shared 4 lane so they will be in competition along with other highway improvements for funding. Local participation in transportation funding could also be critical in what highway gets improved. The PCEDC Board was receptive to hosting another Highway 54 Coalition meeting and suggested the October meeting. That would give them time to meet with the City of Pittsfield in September.

#### **Committee Updates**

Business Retention/Workforce Development – The Committee has dates for fall rollout with Pleasant Hill and Pittsfield and will be schedule Griggsville and Western. Because the program is not available to all grade brackets, there is a need for a lot of volunteers for application and resume training for year 2 and 3.

Small Business Entrepreneurship Committee – Developing sessions and speakers for a Small Business Institute in October at the JWCC new facility.

Promotion/Marketing/Membership Committee – A new membership promotional brochure was viewed. Committee will be meeting to strategize a plan for contacting new members.

Municipal Needs/ Community Issues – Committee is planning an Elected Officials meeting.
