Call to Order

The meeting was called to order by Patrick Conley, Chairman, at 5:30pm. Meeting agenda and April 2017 minutes were provided via email to members and were available for review.

Minutes

After review, Kaye Iftner made the motion to approve the minutes as written, Jeff Hogge second. Motion carried.

Director's Report

Director Brenda Middendorf reviewed the written director's report.

Marketing report

Gary Camarano updated those present on his activities. He continues to promote our Region/County. Upcoming event is the Chicago Innovations Awards. These awards were started 14 years ago. Nominating some of our area businesses for these awards would be a good opportunity for exposure for our businesses and area. He and Brenda continue to work on the possibility of attracting the film industry into Pike County. A location for a film office, an easy permitting process, as well as assembling a "picture book" would all be pieces that need to be in place in order to attract the film industry to our area. Gary will attend an event in Chicago with the Chinese Consulate. At this event, he will promote our area agribusinesses and also try to arrange a date for a future event in our area. Gary has negotiated for a reduced price for advertising in the *Expansions Solutions* magazine. These ads would promote our area and could possibly feature those business nominated for the Innovations Award. The cost for a half page ad for 2 months would be \$1700.

Closed Session

Old Business

The Employer Workshop and Job Fair was held May 4, 2017 at the Pike County Farm Bureau hall. Twenty-three booths were set up at the Job Fair. The employers attending the event were asked to complete a survey. Brenda Middendorf had attached the results of the survey to the PCEDC agenda and meeting packet. Seven employers rated the event as "outstanding" and fourteen rated the event as "good." There were no participants that rated the event as unsatisfactory, fair or poor. Likewise, IDES (Illinois Department of Employment Security), was well pleased with the event and would like to partner with PCEDC on future workshops and job fairs. Another like event maybe planned for the fall. It was also felt that having the Employer Workshop the same day as the Job Fair was a good idea. John Wood Community College also participated and registered guests. The meeting room was open so that those job seekers in attendance could use the space to fill out applications and immediately return them to prospective employers at the Job Fair. According to the survey, 73 resumes were received, 5 interviews were conducted that day, 12 provisional/conditional job offers were made and 2 firm job offers were extended.

New Business

Energy Innovation Workshop is scheduled for June 8, 2017. The workshop will begin with registration at 8:30am. Lunch will be served at 11:30am and the afternoon session will begin at 12:00pm and last until approximately 3:30pm followed by a time for questions & answers. Hwy 54 Corridor Update. The Missouri Highway and Transportation Commission will award the design-build contract for construction of the new Champ Clark Bridge on June 29 at its meeting in Pike County, Missouri. Brenda Middendorf shared the brochure that Pike County, Missouri has made highlighting lodging, attractions and services in their area. PCEDC will also assemble a brochure with information on the Pike County, Illinois area as well. Brenda also provided samples of the banner to be used which also includes the Pike County, Illinois side of the map. Several dignitaries who will be attending the award announcement as well as a Champ Clark Reception on June 28 will be flying into the Pittsfield airport, where Brenda will display the banner. The dignitaries will then be transported by MoDOT to the reception in Louisiana, Pike County, Missouri to be held at Riverview Park. PCEDC, State of Illinois and Pike County, Illinois officials have been invited to also attend the reception at Riverview Park in Louisiana, Missouri.
