At each PCEDC Annual Meeting, 3 directors are elected to serve three year terms. The nine member board is comprised of five directors elected from qualifying public sector voting members representing the County of Pike and municipalities and four directors are elected from qualifying voting members representing the private sector. One public sector and two private sector positions were elected on April 7.

PLEASE SUPPORT NEW PHILADELPHIA FOR INCLUSION IN THE NATIONAL PARK SERVICE

Soon a Pike County landmark could become a National Park and a tourist destination. A public hearing about the National Park Service plans will be held on May11 from 6:00 pm to 8:00 pm at the Pike County Farm Bureau Building. There, residents can talk with local and federal officials about the proposal and actively support the National Park status.

The story of New Philadelphia is extraordinary: through a variety of enterprises, town founder Frank McWorter purchased freedom for himself and at least fifteen family members. In addition, McWorter purchased property in Illinois, a free-state, where he moved from Kentucky with his wife, three free-born children and a son freed from bondage.

McWorter made history in 1836 as the first African American in our nation to plat and legally register a town. New Philadelphia became a community where formerly enslaved and free-born African Americans lived alongside European Americans in one of the most racially strident eras of our country's history. You can actively support New Philadelphia for inclusion in the National Park Service by submitting your comments on inclusion to: <u>http://parkplanning.nps.gov/New_Philadelphia_Special_Resource_Study</u> from April 11 to June 11.

Here are a few key points that you may want to use in your remarks:

- Direct management by the National Park Service (NPS) would permanently protect New Philadelphia from development and inappropriate use of the land, ensuring preservation of the site's archaeological integrity for future study of a 19th century racially diverse community.
- The worldwide prestige associated with the National Park Service far exceeds the resources available through local management to attract visitors.
- New Philadelphia represents themes important to all Americans: the struggle for freedom, opportunity and love for family principals that are relevant today.
- New Philadelphia is an inspiration for what can be accomplished through determination and resilience. Settlers cleared and cultivated sparse grassland to create productive farmland – an inspiration of what can be accomplished by determination and resilience.
- Free and formerly enslaved African Americans lived along side European Americans during one of the most racially strident eras of our country's history.
- Current management and land owners could serve in advisory positions to the National Park Service following New Philadelphia's inclusion in the park system
- Local residents could volunteer time and service at the site
- New Philadelphia's inclusion in National Park Service generated literature and advertising through the wide variety of electronic and print media, including the popular NPS Passport to Your National Parks program, would introduce and familiarize the nation and the world to New Philadelphia.

New Philadelphia was listed on the National Register of Historic Places in 2005, designated a National Historic Landmark in 2009, and included in the National Park Service National Underground Railroad Network to Freedom program in 2013. There is currently no other comparable site represented in the 410 units of the National Park system. Only 24 of the 410 units, less than 6%, of the National Park Service are directly associated with African-American history. Your support for this project is crucial for making this place nationally recognized by inclusion into the National Park Service.

Your comments can profoundly affect NPA's inclusion in the National Park System.

PCEDC ANNUAL MEETING 2016

Demonstrations were provided of their laser using 6,000 watts of laser cutting power to rapidly cut very complex and high quality parts. Other demonstrations included the press brake, where 258 tons of power goes to work with the graphical touch screen control, making short work of many complex parts.

WORKFORCE READY!

If you happen to see someone with this t-shirt, you are in the presence of a Workforce Readiness Certificate awardee! The WRC Program is in it's second year with 56 participants in all four school districts. The program provides recognition and endorsement of those students who have successful-



ly met the criteria required to earn a "Workforce Readiness" Certificate. Data, both quantitative & qualitative, including attendance, disciplinary record and soft skills is collected on students throughout the year. Businesses recognize the certificate as an endorsement by Pike County Schools that the student is ready to successfully enter the workforce. The certificate gives students a head start in the market place and serves as a stamp of approval when the student is applying to a college or for a job. Our students must be armed with the skills they need for employment. JWCC ANNOUNCES PLAN TO RELOCATE

In response to community and advisory council feedback, John Wood Community College Trustees will consider a lease proposal during their April 20 board meeting for a new facility to expand offerings and better serve the Southeastern portion of its district. The Southeastern portion of JWCC's district includes Pike County and portions of Calhoun, Scott, Morgan and Cass counties.

If approved by Trustees and the Illinois Community College Board, the proposed lease will be for the former JDL building adjacent to the Pittsfield Industrial Park.

The new facility, which will be named the JWCC Southeast Education Center, includes 9,700 square feet on the main level and includes additional amenities not currently available in the College's existing center.

In addition to classrooms and offices, the center will include a space for community special events and training, a cyber café area for public use connected to fiber optic high-speed internet, and upgraded laboratory space for certified nursing assistant and pre-requisite nursing courses. Another 8,700 square foot of space on the second level of the building will be available for future expansion.

Trustees feel the new lease arrangement is the best use of dollars currently allocated for a facility and an investment in the future education of residents in the communities of the Southeastern portion of JWCC's district.

"The college is committed to this area and this facility is the result of an extensive search," JWCC Board of Trustee Chair Jim Gay said. "We want to use our existing resources wisely and invest in future enrollment growth in this area by upgrading the facility in which we deliver enhanced educational programs and services. A working college-community partnership will be key for this facility's long-term success."

In addition to an upgraded facility, the College has expanded programs and services in the last year based on key recommendations from community members and JWCC Southeast Advisory Council. These include free college readiness courses in math at the area's high schools, expanded Smart Start concurrent enrollment course offerings and scholarships to help high school students earn college credit, new JDub Academy for 3rd through 6th graders, expanded community based outreach personal enrichment courses, career exploration services, customized training conversations with area businesses and workforce training classes.

JWCC plans to move operations from its current location at 1308 W. Washington in Pittsfield to the new facility in the fall of 2017.
